WHEREAS, it is the desire of the board members of the Mid-Ohio Regional Planning Commission (MORPC) to recommend a unified date by which all central Ohio municipalities will schedule Trick or Treating; and

WHEREAS, MORPC's members recommend that when October 31 falls on the weekend nights of Friday, Saturday, or Sunday, Trick or Treat would be held on the Thursday prior to October 31. If October 31 falls on a Monday, Tuesday, Wednesday or Thursday, it would be held on October 31. The time for the event would be between 6:00 pm to 8:00 pm.

BE IT RESOLVED BY THE MID-OHIO REGIONAL PLANNING COMMISSION:

Section 1. That the Commission recommends a cooperative date and time period during which Trick or Treat will take place in central Ohio communities.
