All communications, including requests for additional information and approved permits, will be sent by email. 3. Fees and/or construction bonds may be required. The contractor/applicant will be notified of fees before permitting approval. 4. Work cannot begin until an approved permit has been issued and any applicable fees have been paid in full.

APPROVAL CONDITIONS:
<ol style="list-style-type: none"> 1. By state law, the contractor/applicant must contact the Ohio Utilities Protection Service, OUPS, at least 48 hours but no more than 10 working days (excluding weekends and legal holidays) before beginning any digging by calling 8-1-1 or (800) 362-2764. 2. All lanes on all City streets are to remain open at all times and be maintained in safe and passable condition during work. If lane closures are necessary, the contractor/applicant must contact the Department of Public Service and Engineering at (614) 342-4005 or ROW@gahanna.gov at least 2 business days in advance of any lane closure. Lane closures are limited to 9 AM to 3 PM, Monday through Friday. It is the responsibility of the contractor/applicant to provide traffic control devices and other safety measures as required by the Ohio Manual on Uniform Traffic Control Devices. 3. Notify the Department of Public Service and Engineering of all excavation work at (614) 342-4005 or ROW@gahanna.gov at least 2 business days prior to beginning excavation. 4. All concrete formwork shall be inspected and approved by the City prior to concrete being placed. Contact the Department of Public Service and Engineering at (614) 342-4005 or ROW@gahanna.gov for inspection of all concrete formwork at least 2 business days prior to placement of concrete. 5. The ROW permit expires on the proposed end date unless otherwise noted. If the contractor/applicant needs an extension, they must contact the Department of Public Service and Engineering at (614) 342-4005 or ROW@gahanna.gov before the proposed end date. 6. It is the responsibility of the contractor/applicant to restore all areas involved in this work to a like or better condition and must abide by the rules and regulations of the City of Gahanna and the State of Ohio.
